# REPORT BHARATIYA MUSLIM MAHILA ANDOLAN MAHARASHTRA UNIT JANUARY TO JUNE 2012

#### A. MUMBAI DISTRICT REPORT

#### a. BMMA-Sehr

The BMMA unit launched its work with young girls. The initiative is called Sehr which means 'dawn'. The following activities were undertaken with them:

- The launch happened as BMMA Maharashtra Unit participated in the Human Dignity Foundation [HDF] project which involves a study on issues of young women in India. The study is happening in three cities of Mumbai, Hyderabad and Chennai. The study is meant to throw up challenges facing the young in India and also give programmatic suggestions to be carried out for the growth and development of young girls. The girls participated in the Focussed Group Discussion organized by Action Aid-HDF to understand the issues of young girls in the city of Mumbai. BMMA also coordinated the study in six localities of Mumbai in collaboration with local CBOs.
- The girls addressed a press conference in Mumbai where the condemned the Delhi High Court judgment which validated a Muslim marriage at the age of 15. Alisha Patel, Heena Shaikh, Rukhsar Siddiqui, Zeenat Shaikh and Iram Siddiqui spoke to the press confidently and said that they want to educate themselves and become economically independent. The judgment is not in tunes with the time and does not reflect the aspirations of young Muslim girls. The BMMA activists demanded codification of Muslim law as a codified law would end the arbitrariness of judicial decisions.
- Mr. Nemat Shaikh from Maulana Azad Financial Corporation gave a talk on various career possibilities for girls who have passed their SSC and HSC. 10 girls attended the talk
- The girls participated in the campaign for the implementation of the Sachar Committee report. They visited the Haji Ali Dargah, Maqhdoom Shah Baba Dargah, Baba Bahauddin Shah Dargah, and the Kamli Shah Baba Dargah. The carried the banner and prayed that the government develops good intention to work towards implementation of the report.

#### b. BMMA-Udaan

The Unit initiated its work with children as part of its long term association with Action Aid. Two localities of Navpada and Islampura have been selected for working with children. 200 children from each locality have been identified. A series of activities were held with them:

- A cultural programme was held in Islampura where out of the 200 selected children, 70 children came. the sang songs and danced to music. Snacks and gift items were distributed to them. The children also participated in the drawing competition.
- A similar programme was held in Navpada, Ghasbazaar. Around 100 children came for the programme. Drawing competition was held along with singing and dancing. Refreshments and gifts were given to all. The best drawings were also given prizes.

# c. Area Report

The BMMA unit is active in 6 localities in Mumbai. It carries out these activities through area leaders.

#### D. CONSOLIDATED STATE REPORT

# **State Council Meeting:**

In the six months between January and June, 2 State Council [SC] meetings were held. The first SC was held in Mumbai. The District Conveners [DC] reported about their activities. The DCs also participated in the consultation on codification of Muslim law held in Mumbai. A session on 'Leadership' was taken by Mr. Shriharsh Kaushik who is associated with BMMA since its inception and has been regularly conducting training programmes for the Maharashtra unit. Mr. Salim Shaikh from Muslim Coordination Committee also spoke to the DCs. Dr. Mallika Mistry also shared her thoughts.

The second SC meeting was held in Agakhan Palace, Pune. It was organized by Saeeda Jamadar who is the DC of Pune. On the first day a press conference was held to condemn the judgment of the Delhi High Court regarding the age of marriage of Muslim girls being validated at 15. The coverage was good. Mr. Salim Shaikh from Muslim Coordination Committee apprised the SC about the challenges faced by Muslims in the country as well as in Maharashtra. Noorjehan Safia Niaz gave an overview about the vision, objectives and activities of BMMA and urged them to take leadership of the community. A big group of Muslim women from Daund had come for the meeting. They expressed their desire to join BMMA and shared in details about a case of woman who was orally divorced. Khatoon Shaikh, State leader of Maharashtra agreed to visit Daund and organize women in that locality.

In the public meeting held in the evening, the BMMA was honoured to have Ms. Shobana Ranade amongst them. She is a Gandhian and a freedom fighter. Amongst many other responsibilities she is the trustee of Kasturba Gandhi N.M Trust. She expressed her support and solidarity to BMMA and remarked that AgaKhan Palace has seen many historical moments of freedom struggle and it is only natural that any movement for social justice will be successful if started from here. Mr. Siddharth Dhende, sitting corporator from Yeravda and a practicing doctor, who also supported BMMA in organizing this meeting, called for dalits and Muslims to come together to fight social injustice and marginalization.

# **Campaign Activities for Sachar Committee Report [SCR]:**

Prayers were offered by BMMA for speedy implementation of the SCR

Thirty activists of BMMA visited the Maqhdoom Shah Baba Dargah on 28th June 2012 to pray for the speedy implementation of the Sachar Committee report. They walked from the L.J Road till the dargah in a procession, carrying the banner which asked 'Sachar Committee Report – Thande Baste Mein?' BMMA activists have been demanding an effective implementation of the recommendations of the Sachar report. It has been one of the nationwide campaigns of BMMA to put pressure on the government to work genuinely for the development of the community. The shop owners near the dargah offered their support to the campaign, some offered tea to the women activists, and others suggested that we should intensify our agitation and put pressure on the government. They offered to join in the campaign. They then visited the Baba Bawuddin Shah Dargah at Churchgate and the Haji Ali dargah on 30th June 2012. They prayed for the well being of the community and prayed that the government becomes sincere about the implementation of the report.

#### **Research and Documentation**

National Study on Initiative of Muslim Women:

BMMA along with Observer Research Foundation organized a round table on 'Defining the role of Government, NGOs and Media in the Inclusive Development of Muslim Women.'It was attended by activists, academicians, journalists, civil society groups and individuals who were concerned with improving the status of Muslim women.

This roundtable was an important part of a study done by ORF and BMMA to document the efforts and initiatives of NGOs managed by Muslim women across the country. The round table was attended by prominent persons like Shabistan Gaffar from National Commission for Minority Educational Institutions, GOI, Arefa Khanum Sherwani from Rajya Sabha Channel Dr. Zeenat Shaukat Ali from

WISDOM Foundation, Javed Anand from Muslims For Secular Democracy, Khatoon Shaikh from Bharatiya Muslim Mahila Andolan, Uzma Naheed from Iqra, Nasreen Fazalbhoy from Mumbai University, Farrukh Waris from Burhani College. More than 25 activists from BMMA took active part in the round table and gave their suggestions. Mr. Sudheen Kulkarni from ORF gave the concluding remarks and Ms. Noorjehan Safia Niaz from BMMA gave a brief introduction of BMMA and the objectives behind the study undertaken by both the organizations.

The round table concluded with the opinion that the Muslim community is an equal partner in the national community. The diversity of the country must be maintained and at the same time each community must get a feeling that they are participating in national life. The aim is integration and not assimilation. The stereotypes of various communities, especially about the Muslim community exist because there is no communication between the Muslims and the non-Muslims.

# Nyaya Panchayat Report:

For the first time an effort was made to document the activities of the nyaya panchayats run by Muslim women. Since 1995 the Mahila Shakti Mandal [MSM] has been offering legal aid services to poor women, especially Muslim women. This report documents the case intake of MSM from the year 2007 to 2011. This 5 year report also analysis the nature of cases reported and gives an insight into the socioeconomic status of Muslim women.

#### **Network and Alliance Building**

The BMMA activists were able to meet 22 Action Aid partners in the Regional Partners meeting in Lonavla. A presentation on the issues of Muslim women from a feminist perspective was also done.

The Common Purpose team visited BMMA office. Common Purpose is a leadership development programme for corporate, NGOs and government officials. As part of the experiential learning the team of Common Purpose visited BMMA office to understand the various aspects of leadership.

Participated in the Women's Day rally along with other women's organizations

Participated in another Women's Day programme organized by Kokan Muslim Education Society in Bhiwandi,

Participated in women's day programme organized by Navnirman Vikas Sanstha Participated in Bint-e-Hind award ceremony. Khatoon Shaikh received the award

#### **Peace and Justice**

BMMA jointly organized the programme to commemorate the 10 years of Gujrat genocide. More than 100 BMMA activists attended. 10 years after the state sponsored attack on the Muslim community, justice still eludes the victims of the violence. Personalities like Dolly Thakore, Rahul, Sanjeev Bhatt attended the meet. More than 700 people attended the commemoration.

#### E. NATIONAL REPORT

#### **Consultations on codification:**

The first 2-day consultation of the year was held in ISI, New Delhi on 4th and 5th February 2012. It was in collaboration with Centre for Study for Society and Secularism [CSSS]. The objective of the workshop was to firm up the draft of the codified law prepared by both the organizations. One can say that for the

first time a very open, frank and constructive debate and discussion took place amongst all those stakeholders who genuinely wanted to address the issue of legal reforms. A very important beginning has been made which will be followed by many more such consultations in different states of the country as well as nationally. The issues given above will be further discussed and debated with many more groups and organizations. The consultations were guided by Dr. Asghar Ali Engineer, Dr. Zeenat Shaukat Ali, Dr. Tahir Mehmood, Justice Akbar Ali, Justice Shamsuddin, Prof. Wani, Javed Anand and Zakia Soman. The draft of CSSS was prepared painstakingly by Qutubjehan Kidwai and that of BMMA was prepared by Noorjehan Safia Niaz.

On 7th April 2012, Bharatiya Muslim Mahila Andolan [BMMA] and Muslims for Secular Democracy [MSD] organized a one-day consultation on codification of Muslim family law. The consultation was part of the campaign initiated by BMMA to codify the Muslim law. The consultations were guided by Dr. Zeenat Shaukat Ali, Adv. Kirti Singh, Zakia Soman and Javed Anand. The draft law was read out by Noorjehan Safia Niaz who has been coordinating this campaign on behalf of BMMA. more than 100 women and men participated. Organizations like Stree Mukti Sanghatana, SNEHA, Navnirman Samaj Vikas Kendra, Muslim Samanway Samiti, WISDOM Foundation, Hukook-e-Niswan Sanghatana, Mahila Shakti Mandal, Samjhauta Mahila Mandal, Sahyog Mandal, BMMA District leaders from Nasik, Sholapur and Pune, AIDWA, Jagruti Kendra, Hamraaz Legal Cell, Research Centre for Women's Studies-SNDT Women's University, Centre for Study of Social Exclusion and Inclusive Policy-SNDT Women's University, Action Aid, Don Bosco, NEEDs and Vikas Adhyayan Kendra. Adv. Nirmala Sawant Prabhavalkar, member of National Commission for Women and former Mayor and Chairperson of State Commission for Women attended this consultation as a member of the women's movement and extended her support to the process. Although not invited 7-8 women and men members of Jamaat-e-Islami Hind, attended the workshop. They raised many questions on many clauses and on many other they agreed with the draft.

# **Inclusion of West Bengal in BMMA:**

For BMMA West Bengal [WB] is a very important state as 25% of its population comprises of Muslims. It was proposed in the National Council of BMMA that a visit must be paid to Mahila v Shishu Vikas Kendra in Howrah to understand their work and also their willingness and ability to carry out BMMA work in WB. Rahima Khatoon who is the secretary of the said organization arranged the meeting in Howrah and Kolkata.

Zakia Soman, Noorjehan Safia Niaz and Farhat Amin visited the organization on 28 and 29 March. On day one, a meeting with the staff of MSVK was organized where in depth information was given about BMMA. The staff asked questions and also shared their work with the BMMA team. They work in 5-6 districts of WB though they do not have a base in Kolkata. The organization has a large team and work closely with women. The president of the organization also joined the meeting.

After the meeting with the staff, a public meeting was held which was attended by about 50-60 women. Again information about BMMA was given to all. A brief talk on codification of Muslim law was also held. Women asked questions related to legal problems of Muslim women.

The organization runs a small workshop where they make sanitary napkins. The team saw the machine and the process by which the napkins are made. They have just started the process and are learning as they go along. Community visit was held in the nearby village in the evening. More than 40 women attended the meeting. It was held in one of zari workshops. They shared about their daily lives and their daily struggles. Except for a few most of them had more than 4-5 children. Their husband's did zari work or went to Kolkata for work. Women also did zari work. Although Kolkata is just 2 hours away from this village, there are no street lights. It is pitch dark except for lights from the houses.

Next day a consultation on codification was held in Kolkata. Women from different organizations came for the consultation. The draft was shared with them in detail. Many suggestions came forth. The gathering agreed that codification is the answer to the legal problems of Muslim women.

### Districts visits in Karnataka [Hubli, Koppal and Dharwad]:

The State Convener of Karnataka, Nagma Shaikh and District Convener of Koppal district Noorjehan Nirelgi had organized a meeting with Muslim women in Koppal on 20th and 21 March. In this meeting, information about BMMA was given by Noorjehan Safia Niaz, Founder Member of BMMA. Muslim women in this district also shared about the difficulties that they face. Many women who were senior citizens were demanding senior citizen's card. They also did not have any facility by the government. They did not have any document which would help them to get old age pension or widow pension. They also did not have ration card or health card issued by the Karnataka government. This health card also called the Vajpayee card would help them get free medicines but they do not have it.

A small consultation was held with lawyers on codification of Muslim law. Adv. Abdul Gani Afsar and Adv. Qasim who were in favour of codification of Muslim law offered to organize a bigger meeting of lawyers who would give their support for the reforms in the law.

A press outreach was also organized which was facilitated by Mr. Sadiq Pasha. Next day more than 5-6 papers covered the event.

The team of BMMA also met lawyers in Dharwad district and shared the idea of codification with them. They whole heartedly supported the idea and offered their help in our future endeavours. In the Hubli district more than 50 Muslim women attended the meeting organized by District Convener of Hubli, Shamim. The women here were very enthusiastic and showed keen interest in taking leadership and improving their living conditions. They have promised that in a year's time they will solve the problems of exorbitant water bill, overflowing gutters and scholarship for girl's education. They all promised to support their district leader, Shamim and solve their problems which they have been facing for such a long time. The efforts of BMMA were supported by Mr. Aziz Mulla, Mr. Basheer and Mr. Ayaz. It was heartening to hear these men offering their full support to Muslim women leaders and also supporting the campaign on codification of Muslim law.

## **Participation in Sauhard Manch:**

BMMA activists attended the meeting of Sauhard manch in Ahmedabad. Presentation on BMMA was done.

#### **Students Placement:**

10 students of first and second year MA [Social Inclusion and Exclusive Policy Centre of SNDT University] were place in BMMA for their field work. They participated in the activities of the unit and one of the students also did her research with young Muslim girls. Ishika Sur from Kolkata and Rafia Zaman from UP also visited the BMMA Unit and understood the issues of Muslim women.
