The session began with a game followed by a discussion on the work done by the women and an approx value for the work done by the woman in a month. The work done in the house by every woman is importance and it must be respected even if it is not paid for.
- Session held with 54 Sehr group girls at Golibar. Session began with a discussion on whose name (mother/father) is used with the identity of any individual and why and a session on power and gender in Jan'17.
- Session was on unpaid care work held with 45 Sehr group girls at Golibar. Discussion held on the work done by woman and man, approx valuation for the work done by woman. The work done in the house by every woman is importance and it must be respected even if it is not paid for in Jan'17.
- 1 half day session on Gender held at Golibar in Feb'17. The session included songs and games played to understand the perspective of gender v/s sex and discussion on identity. Session was attended by 38 young girls.
- Basic gender training with Sehr group held for 2 days was attended by 24 and 18 girls respectively in Apr'17.
- One half day Gender training sessions held training in May'17 at Bharatnagar. 12 girls were present for both the sessions.
- One half day session on discrimination, revised the portions of the previous session. Discussion of the Social and Natural difference. The session was attended by 16 girls in Jun'16.
- Sessions on gender training held at Golibar with new group of Karwaan centre with 8 girls. Session was on the topics unpaid care work in Sep'17.
- Basic Gender training held at Gyaneshwar nagar in Nov'17. Session held with 18 girls. Gender
 discussion on Natural v/s Social difference followed by sharing of BMMA work. Few mothers also
 requested to have a session on employment for the children.
- Basic Gender training held at Tata Colony, Bharatnagar in Nov'17. Session held with 10 girls.
 Activities and discussion on identity of self by adding mother's name to their name. Beti Hu Mei Beti song was sung by the girls and discussion of the aspiration of the girls for self and their family.



SRHR Training (254 girls)

- Session on SRHR, know your body was attended by 34 girls in Jan'17. The session was taken with the help of the charts on the parts of the body. The place where each organ is located in the human body, its role and importance was shared and discussed.
- Session was taken on Sexual and Reproductive health. 43 girls attended the session on menstruation cycle, uterus, ovaries, how is the child formed, gender determination of the child in Jan'17.

- 1 half-day session on Gender and Health held at Golibar in Feb'17. Know your body, explanation on menstrual cycle, myths and cleanliness. Session was attended by 32 young girls.
- 1 half-day session on Gender and sexual and reproductive health held at Golibar in Feb'17. The session was on sexual and reproductive health. Session was attended by 38 young girls.
- Two half day Gender and Sexual and Reproductive Health training at Golibar centre. 25 and 17 girls were present for the sessions in Apr'17.
- Half day training session on SRHR held on 24th May'17 at Bharatnagar was attended by 12 girls.
- A half-day session on sexual and reproductive health held was attended by 17 girls in Jun'17. After the session few girls raised queries i.e. first woman is made to use so many symbols to know that they are married then why is there no such symbol attached to men to show that they are married, second house work is of all the members where is it written that the house work should be done by women.
- Personal hygiene meeting held at Bharatnagar Karwaan centre. 20 girls were present in Jul'17.
- 2 sessions on SRHR training held at Golibar with new group of Karwaan centre with 8 girls each session in Sep'17. Session was on the topics of health and body parts, menstruation and myths on menstruation, sexual and reproductive health.



MPL Draft Law Training (18 girls):

• 3 half-day session on MPL draft held in Oct'17. Sessions was attended by 6 students at Golibar. First session was on the history of Islam, the difference between Hadis, Quran and Shariyat and discussion with the students. The second session was held on the Constitution and BMMA values

Discussion with the police offices with the girls on the issue of Safety of Girls."
- Obtained permission for visit to Bhabha Hospital and Kherwadi Health Post on 17th Aug'17. Visit to the hospital on 18th Aug by 7 BMMA leaders to felicitate mothers on who have given birth to girl child. Visited Bhabha hospital and facilitated the doctors, nurses, ward boys, helper staff and mothers with flowers and gifted 60 new born baby girl child with a gift of jablas, napkin and hood cap. At Kherwadi Health Post they distributed and facilitated the Doctors, women nurses, helper staff and mothers with flowers and gifted 6 new born baby girl child with a gift of jablas, napkin and hood cap.
- Meeting with the girls to conducted safety walks with in Golibar along with Karwaan students on the issues of health and safety of girls/women. 14 women along with 3 BMMA leaders conducted the safety walk audit in Golibar to understand the conditions of the road / bi-lanes, gutters, unsafe area i.e. poor cleanliness and hygiene, open gutter, water logging in the lanes/bi-lanes, no lighting street in the surrounding on the transit camp are due to which eve teasing takes place etc. photos were

- taken, report to be written by a BMMA leader and area mapping drawing done by the Karwaan students.
- The next step is to share the finding/issues in the community along with photos to the BMC and Police Station with recommendations from the girls and follow-up of the same with BMC and Police department.

Gender Sensitization (209 children)

• Two day gender training was attended by 18 and 13 boys respectively. The session included craft work, charts and discussion was focused on gender discrimination with girls and how to provide equal rights and opportunities for girls and boys. By the end of the session the boys took an oath that

they will support their mother, sister, cousins and friends in their decisions of clothes, food, education, life partner etc.

- Half day Gender Training held at Bharatnagar was attended by 22 boys.
- One half day session on discrimination, revised the portions of the previous session. Discussion was on unpaid care work. The session was attended by 22 boys.
- 2 meeting held with the Udaan group at Bharatnagar on unpaid care work and discrimination between Boys v/s Girls. 17 and 20 boys were present for the meeting.
- Gender session, Drawing and Games activities held with 43 and 38 children boys in Khar East Shantilal compound on 17th Dec'17 and 24th Dec'17.
- Gender Training Activity held at Bharatnagar with children to add parents name along with their name. Many children easily added their fathers name by found it difficult to add mother's name. A discussion was held with 16 children on their views of adding mother's name. Only one child felt that both parents name should be added.

- Session on the draft Muslim Personal Law of BMMA in Jan'17 held with 27 young boys of Bandra West. An interactive session was to understand the rights on MPL as per Quran and as per the draft.

CODIFICATION OF MUSLIM FAMILY – REPORT OF 2017

HIGHLIGHTS OF THE YEAR 2017

- 15 women qazis, first time in the history of the country, a formal training of Muslim women to become qazis. First divorce [mubarah]done by Qazi Zubeda Khatoon Shaikh
- Victory in the Supreme Court against triple talaak.
- History made on 28th December, the ill-conceived Bill was passed by Lok Sabha. Though cleared in Lok Sabha it did not get passed in the Rajya Sabha. But a victory nonetheless as for the first time, a healthy discussion on abolition of triple talaak in both the houses of Parliament took place. Victory of the struggle of ordinary Muslim women
- Awards Parhit Seva Sangh, Justie Sunanda Bhandare Award, Mumbai Mirror Hero Award
- Book on Haji Ali struggle and success released through Notion Press Publications

MPL Advocacy

- Public Interest Litigation was filed by BMMA as impleading in Shayra banu's case. On 22nd August 2017 the judgement came in favour of victims. As directed by the SC, the Parliament was expected to come up with a legislation against the practice. The Bill introduced in the Lok Sabha was passed by due to nationwide objection, it was stalled in Rajya Sabha. BMMA welcomed the Bill but asked for major amendments like including talaak-e-ahsan, making it bailable and non-cognizable on par with other civil laws. Another victory was that all opposition political parties agreed to the legislation with amendments.
- Met CP of Mumbai Police and asked DV Act to be applied to triple talaak victims till such time as a legislation is not passed.
- Coordination with Ex-Chairperson, National Commission for Women for a meeting to discuss the BMMA draft
- Met Mr. Chavan, Chairperson Law Commission and Met Ms. Lalitha Kumaramangalam, Ex-Chairperson, NCW for presenting BMMA draft and for application of DV Act before legislation.

"Improve Public Health Services"

- Visits to V.N Desai and Bhabha hospital to check the functioning of the hospital.

Spoke about the problems faced by the community of i.e. the rude behavior of the hospital staff, Muslim women made to remove burka and enter into the hospital, long lines, shortage of medicine, and shortage of staff during epidemic of Dengue/malaria etc. They noted down the problems and the suggestions suggested shared. They also share details of registering a complaint and helpline nos. They suggested in the meeting add 2 names. BMMA representatives Farheen Sayyed and Bharti Shetty names were suggested from the team two for Dakshata Committee for which letter and photos were submitted to make ID card for the Dakshata Committee. Four Dakshata Committee Planning meeting attended in 2017. Planned Blood Donation camps, Cancer camp and rally at Khar Danda to be held by Bhabha hospital. Discussion to provide medicine in-house and avoid outside medicine, increase the outlets for distribution of medicine, to increase the no of doctors, provide cubical of checking women etc.
- Two BMMA representatives visited to BMC office of Health Department in July'17. Spoke to the head officer Mr. Mohite to plan a Medical camp at Indira Nagar pipeline due the accidental brakeage of water pipe. Dr. Pankaj (Kherwadi health post) and team held a medical camp on 2^{8th} July'17 for Dengue, Malaria etc. Emergency medicine and medical aid was provided in the camp. Spoke to BMC officer Mr. Jayant and got the area cleaned of the derbies due to the water logging and spoke to Mr Jadhav to spread the pesticides for the mosquitoes.
- Bhabha hospital volunteers and 2 BMMA representatives attended the for blood donation camp held at Agripada Vakola in July on Sunday. 50 people donated blood. Dr. Chitra, Mr. Ajay Hariyan and the Vakola co-operator about BMMA and its work and they were asked us to collaborate with them.
- Two BMMA representatives accompanied Anandi (TISS student) to conduct a survey on the delivery facilities in Government (Bhabha) hospitals. This survey is to understand the problems faced by the pregnant women and to check the facilities available to them in Government hospital.

BMMA leader Sana Patel was invited to sit on the stage and speak of the incident that took place in Bharatnagar and Bherampada.

- Letter give to Salim Bhai (Local Corporator) to repair of the road and remove the parking of old vehicle parked on the road so that BEST / school buses so they can freely move on the road.
- 7 BMMA members visited Nirmal Nagar police station and presented the Sr. Officer with flower bouquet and spoke to him about BMMA work in the community.
- 5 BMMA members attended the Mohulla Committee meeting at Andheri West and gave letter to the DCP present to treat Triple Talaq cases under domestic violence act as per the SC judgment 2005.
- Visited to BKC police station with 9 BMMA area leaders to meet DCP meet and gave letter to treat Triple Talaq cases under domestic violence act as per the SC judgment 2005. Meet the BMC ward officer Mrs Sansane at the Police station and shared BMMA work with her.
- 5 BMMA members visited CP office at VT and gave letter to treat Triple Talaq cases under domestic violence act as per the SC judgment 2005.
- BMMA team organised a meeting in the community of Bharatnagar on the Rights of Citizen and the Rights and responsibilities of the Police on 4/11/17. How to maintain Peace and Harmony in the area. Members of Mohulla Committee movement trust was represented by Subham and Dolphin D'souza, Senior Police Officer: Madam Wahare, Community members Asif Bhai, Naseer Bhai, Rauq Bhai were presented with flowers. Training session by Dolphin Sir of Police Department, how to speak to the police officer, how to write an NC and FIR and shared the telephone Nos. of police officials to complaint. The need to understand that all the police officers are not corrupt and understand how the system work and put forth our issues. 63 people were present for the meeting of which 19 were LRP beneficiaries.
- Get-to-gather program organised by the Mohulla Committee Movement Trust at Versova, Andheri West. Program was attended by 5 BMMA leaders. There was a Musical program and Quiz for which there were gifts rewarded followed by dinner. Approx 100 people were present for the meeting.
- 3 BMMA members attended the Mohulla committee movement trust meeting held at Andheri on 16th Dec'17.

Food Security

- 1 meeting on the issues of ration held at Bharatnagar, 12 women were present. Planned a bigger meeting in March.
- Complaint letter on to head of ration office at Churchgate that the quality of grains received is mixed with other particles, good quality grains are black marketed, quantity of kerosene has been reduced and black marketed and palm oil not received. Ration department is supposed to have a meeting in which they will invite BMMA team.
- Accompanied a pregnant women to the hospital for delivery and remained with her for two days till safe delivery (Reshma)
- Visit to Vokola Ration shop. Enquire about how many ration card (1200 ration cards), only 100 people receive ration the balance black marketing and poor quality of grains received at Vakola.
- Visited Bandra East ration office to file a complaint. The office in charge was on leave so will be revisiting them in Jun.
- BMMA area leader meeting held in Gyaneshwar nagar on Ration issues. Total 13 women were present.
- BMMA representative visited the Ration Office to enquire about the details/procedure of the Aadhaar card getting linked to the ration card.

Education

Survey conducted on government school to understand the problems of the students, below were the findings attached

Municipal School, Santacruz, East

- **Problem :** Poor sanitation problem in the school, No computer class and library for 1st to 7th standard. PT teachers restricted female children from playing cricket. Teachers encourage children to go for private tuitions. Partiality in class towards certain students. Quality of mid-day meal is not good and no availability of canteen. Medical checkups are conducted however students have to pay to get the reports. No source of recreation or entertainment. Annual day isn't celebrated.
- **Action:** Gave a letter to the Principal with regard to the above problems. We meet the Principal and discussed the problems of the children. The Principal resolved the problem of sanitation; Girls are now provided equal opportunities in sports activities. Midday meals quality improved.

Maulana Azad School (Golibar)

• The problem faced by the students was caning by teachers for which letter was given to the Principal and discussion held and he ensured that he would speak to the teachers.

Khernagar Muncipal School (Bandra East)

- Meeting with the Principal of Khernagar Muncipal School and lodge complain of teachers for illtreating the girls for wearing scarf to school based on the compliant of the Sher group. Principal called the teacher and spoke to teacher and resolved the problem.
- 3 BMMA representatives visited Khernagar Secondary (Urdu, Marathi. English) School based on the complaint of the Udaan group boys. BMMA members visited the school and spoke to the teacher, principal to understand and help resolve the problem of the students of the sitting arrangements and how to increase the quality of the education.

St Teresa Convent High School (Santacruz)

• Loyanagar BMMA area leader spoke about the problems of education where 4 girls were given leaving certificates. The area leader visited the School with Shiv Sena member but did not help. BMMA sent a letter to the Principal. Meeting was held with the school principal, parents, Loyanagar Area leader and BMMA representatives. In the meeting the principal gave an option of repeating the students as they were very weak. After the meeting it was decided by the students that they were not willing to repeat the year and hence the BMMA Loyanagar area leader got their admission was done in STD 10th in Taraben English School.

Valmikinagar BMC school (Bharatnagar)

- LRP children complained that a teacher used to make the child remove their clothes in front of the class and hit the student. We gave a letter to the Principal to report the abuse. Visit to the Head of BMC School at Santacruz W to complaint speak to Principal on the harassment in the BMC schools of Valmiki nagar, Bandra (E).
- Meeting with 22 women held at Mahim on BMMA and its work with women and importance of educating children

Legal Aid (Aurto Ki Shariya Adalat)

- 189 cases registered in the year 2017 of which 176 cases were registered in Bandra centre and 13 cases were registered in Kalina center.
- 114 cases were resolved in the year of which 69 were from Bandra centre and six from Kalina centre.
- Out of 189, 6 cases were of triple divorce, 7 of divorce application by men and 8 cases of divorce demand by women [khula].

- 32 cases of polygamy have been reported.
- In all, maintenance and compensation worth Rs. 16,25,000 was given to women and gold worth 64 tolas were given to the women
- Four cases have registered cases just for safety.

Case Study

Iqramudin Shakih(25 years) married to Lubna Shaikh (25) at the age of 22 years. Iqramudin Shaikh says "I was informed by Lubna before marriage that she was divorced, yet I agreed to get married to her. After one month of the marriage there were fights between us as she kept comparing me to her previous husband and kept speaking about her first husband. Due to the continuous disputes after a year of marriage she left and went to live with her mother. For two years I waited but things did not seem to work out. I approached Aurton Ki Shariya Adalat (ASA) / BMMA seeking help. ASA /BMMA team called my wife and self for counselling sessions were attempts were made to reconcile us. Total six sessions were held in the span of three months to help us reconcile but it were all in vain. After a tedious 3 months session we both mutually agreed that we should divorce. I agreed to give Lubna her belongings, pay her the Iddat amount and maintenance which amounted to Rs.200000/-. I wish to thank BMMA team to help resolve a lingering marriage problem pending for over two years."

Capacity building of leaders (466)

- 24 leaders were present for the topics of Special Marriage Act Marriage, Talaq, property matters.
- Leadership training held for BMMA leaders at Uran. 30 leaders were present. Session on leadership, team spirit, communication, co-ordination through games, activities and discussion.
- 28 leaders were present for a session on Public speaking session held at Kerwadi office, Bandra (E). Meeting held at Vokola on BMMA and the 5 issues by BMMA. 30 young women were present. The topics were on the problems of the Ration and in public school were also discussed.
- Attended a 2 day session with 3 BMMA leaders on Leadership. Total 50 members from 9 different organisation were present.
- Capacity Building session on Team building at Juhu Beach for the core team attended by 12 members. Sharing and understanding on team spirit.
- Time management session for the core team attended by 12 members. Session on understanding one potential.

Karwaan centre students enacted a Skit on the topic of Halala and tried to create awareness that Halala is not mentioned in the Quran. Two days session held on 14-15th Jul'17 to understand oneself better, understanding one's strength and weakness and letting go the negativity within self and focus on the strength to help bring about change in the self and in our work.

She also questioned the leaders of their opinion and what should be the stand of the organization on the imprisonment clause. All leaders felt that it should be there so that the man will fear to give verbal Talaq and will follow the procedure to give Talaq. BMMA representatives conducted a visit of the student through Bheramnagar (Bandra East) followed by a joint activity by Xavier college representatives for the team leaders and the 15 students studying in Std XI.
