AURTON KI SHARIAT ADALAT

Total of 111 cases were registered with the ASA

- The first mubarah divorce happened through Qazi Zubeda Khatoon of Rahila and Firoz.
- Yaseen- Afreen joint meeting was held and reconciliation agreement was drawn up.
- Prepared Hindi application, notice and request letter of ASA
- Prepared qazi stamp of self and Khatoon Shaikh
- Prepared letterhead of ASA
- After many months of the triple divorce law passing, 2 cases of triple divorce have been reported and one case of polygamy has been reported
- 3 cases of polygamy were counseled on the phone. One woman from Nagpur and one from Vashi have reported that their husbands have married another women during lockdown. Both are fighting their cases in the railways and in the police station respectively.

- Workshops were held with children on mental health by Lia. Through games and exercises children were equipped to deal with their emotions

TRAINING

- Mudrika Awasthi took a session on Dance and Movement Therapy for the BMMA team. The session involved our ability and willingness to use our bodily movements to let go of pent up emotions and to learn to express ourselves through our body. It is fun and therapeutic.

MPL REFORM

Presentations:

- Participated in the Global Launch of the Campaign for Muslim Personal Law Reform by Musawah. This global launch especially in the times of COVID-19 pandemic is a reiteration that these issues continue to play a role in the lives of Muslim women. And that they must not be lost in the havoc which the pandemic has caused. In fact in such times, the incidences of discrimination emanating from personal law increases just as we saw the huge increase in incidences of domestic violence. The monitoring of these incidences is important. To understand this situation, BMMA also participated in an international meeting of Muslim women campaigners for law reform who informed that the incidences of domestic violence has increased. There are incidences of increase in child marriages. Men continue to exploit the vulnerabilities of women due to inadequate laws, poor implementation of laws and in some places, a complete absence of laws and legal machinery.
- Also presented on BMMA and Codification of MFL It was attended by participants from 30 countries and 8 time zones. Apart from valuable insights into the issues and learning from experiences of the participants, important decisions were taken. For e.g. BMMA would want to take up the issue with CEDAW and also play a role in having a regional collaborative platform for sharing strategies.

RELIEF WORK

Over the last 2 months, we received Rs. 1,39,000 as donations/zakat to reach out to families of daily wage earners and migrants. In all we were able to provide 2 months of ration so far to 500 families. These families are from Behrampada, Navpada, Bharatnagar, Wadala, Mumbra, Kherwadi, Dharavi. During Ramzaan, arrangements for iftar was also done. The grains were picked up at the wholesale market at Vashi after due permission from the police. The grains were of loaded and then packets for each family was arranged. The kit thus included oil, rice, wheat flour, dal, tea and other essentials.

Distributed sanitary napkins to 35 women.

Business support to 5 families

Sarees distributed to 16 women through a donor

Demands Towards The Government:

- They believe that hospitals should be state run and not be privatized.
- There should be a fully functional health centre in each slum community.
- The health centre must have the following facilities of general body check-up, treatment for minor illnesses, medicines [tablets, ointments and injections], machines like x-ray and sonography, facility for blood test, ECG, tetanus shots, gynaecology services like regular check-up, sonography etc. and basic health care in case of sudden illnesses and emergencies.
- Doctors, medicines and machines must be available round the clock so that the poor does not have to run from pillar to post. The poor depend on the state run hospitals and state must not run away from its responsibility. The state must spend on medicines, machines and total health care facility for the poor.
- Everyone felt that free medicines and tests should definitely be available in hospitals.

MUSLIM WOMEN LEADERSHIP STUDY

Began the Muslim Women's Leadership Research. Unbudgeted but a crucial study. The study will involve in-depth case studies of all state leaders, founder members and a few dedicated Muslim women other than BMMA. The purpose of the study was to illustrate the role played by Muslim women in the feminist movement. The study involves indepth interviews of 15 BMMA leaders, The study is looking their personal lives, achievements and challenges so that the next generation gets their roles models and inspiration. By the end of December 2020, all 15 interviews were done. The book will be released by March 2021.

MENTAL HEALTH COUNSELING

- Over two months, 23 cases of mental health were provided with phone counseling and therapy. 2-3 sessions each were conducted through phone.
- 4 workshops in the community of Bharatnagar on mental health. Focused on equipping the group with skills on dealing with anger, sadness, guilt and other negative feelings. Each of these workshops was attended by 30 women.
- Similarly, sessions were held with Sehr-BMMA girls on mental health. In all 4 sessions will be held with them. This group comprises of 15 young girls. [see sehr group]
- Mental health training to 30 women and girls through a one day workshop

Ration:

- In the entire month, the volunteers visited 10 ration shops on a weekly basis to monitor the shops. Complaints were also filed with the ration office. Social media like the FB and Twitter were used to reach out to the press and the government officers concerned.

- 131 forms of families submitted to the ration office of those who did not get ration.
- A Whats App group has been formed with the shop owners and BMMA leaders to keep track of what is available in the shops.

Health:

- 2 people got medical aid.

Livelihood:

- Ex-Karwaan student started her own classes and for the first time completed the advanced beautician course. 10 girls were felicitated on completion of the course.
- Rs. 17000 was used for facilitating micro finance for women entrepreneurs

Security:

- Meeting of the Mohalla Committee Movement Trust of all 6 zones to discuss the COVID situation.
- BMMA members attended Mohalla Committee Movement Trust meeting where Mani Mistry spoke about unity of various communities. We spoke about our attempts of getting children of different communities to come together on festivals. She also spoke on mental health.
- Meeting of the Mohala Committee Movement Trust held in Kherwadi and Bharatnagar. 16 young men attended the training
